# LTCH QRP Annual Update Table for Reporting Assessment-Based QM and standardized patient assessment data elements Affecting FY 2023 posted

An update to the Long-Term Care Hospital Quality Reporting Program (LTCH QRP) Annual Update (i.e. Annual Payment Update [APU]) Table for Reporting Assessment-Based quality measures (QMs) and standardized patient assessment data elements to the Centers for Medicare & Medicaid Services (CMS) is now available. This document has been updated to reflect the data elements required to meet the APU minimum data completion threshold for Fiscal Year (FY) 2023. Additionally, an update to the LTCH QRP Data Collection and Final Submission Deadlines for the FY 2023 LTCH QRP is available. This document has been updated to reflect the data collection and final submission deadlines required to meet the APU minimum data completion threshold for FY 2023.

#### Reminder of Upcoming Data Submission Deadline

The submission deadline for the Long-Term Care Hospital (LTCH) Quality Reporting Program (QRP) is approaching. LTCH Continuity Assessment Record and Evaluation (CARE) Data Set (LCDS) assessment data and data submitted via the Center for Disease Control and Prevention (CDC) National Healthcare Safety Network (NHSN) for January 1 – March 31 (Q1) of CY 2021 are due with this submission deadline.

Assessment data must be submitted no later than 11:59 p.m. on August 16, 2021.

It is recommended that the applicable Centers for Medicare & Medicaid Services (CMS) Internet Quality Improvement and Evaluation System (iQIES) reports and NHSN analysis reports are run prior to each quarterly

reporting deadline to ensure that all required data were submitted. We encourage you to verify all facility information prior to submission, including CMS Certification Number (CCN) and facility name.

CMS sends informational messages to LTCHs that are not meeting Annual Payment Update (APU) thresholds on a quarterly basis ahead of each submission deadline. ### PPS for LTCHs; Updates to the QRP for Federal FY 2022 CMS-1752-F

On August 2, 2021, the Centers for Medicare & Medicaid Services (CMS) issued a final rule, CMS-1752-F (Prospective Payment System [PPS] for Long-Term Care Hospitals [LTCHs]; Updates to the Quality Reporting Program [QRP] for Federal Fiscal Year [FY] 2022) that provides updates to and finalized proposals for the FY 2022 LTCH QRP. This rule includes one new finalized measure, the COVID-19 Vaccination Coverage among Healthcare Personnel (HCP) Measure, as well as updates to the specifications for the Transfer of Health (TOH) Information to the Patient-Post-Acute Care Quality Measure and announces the public reporting of the LTCH Ventilator Liberation Rate and Spontaneous Breathing Trial measures for the LTCH QRP. In addition, CMS finalized a modification to public reporting for the LTCH QRP quality measures in order to accommodate the exception of 2020 Q1 and Q2 data.
