

# National Quality Strategy

In 2022, the Centers for Medicare & Medicaid Services (CMS) launched the **National Quality Strategy (NQS)**, a cross-cutting initiative to advance the agency’s goal of ensuring the highest quality care and best health outcomes for all individuals.

The CMS NQS aims to improve health care quality for individuals across the lifespan and the continuum of care, promoting a more equitable, safer, and outcome-driven health care system.

Quality is essential to value—the highest quality care at the most affordable cost. By emphasizing quality across CMS programs, the agency’s NQS advances resilient, high-value care for all.

**Mission:**

To achieve optimal health and well-being for all individuals.

**Vision:**

CMS, a trusted partner, is shaping a resilient, high-value American health care system that delivers high-quality, safe, and equitable care for all.

## CMS NQS Goals

The CMS NQS has four priority areas, each with two goals. The eight goals are interconnected and provide a unified vision for improving the quality of care for the over 160 million individuals with Traditional Medicare, Medicare Advantage, Medicaid and Children’s Health Insurance Program (CHIP), and Marketplace coverage.



## Implementing the CMS NQS

## Highlighting Key Quality Initiatives



### The Universal Foundation: Aligning Quality Measures Across CMS

The Universal Foundation is an initiative to align measures across CMS quality programs. The Universal Foundation is a set of measures that focus provider attention, reduce reporting burden, identify disparities in care, and prioritize development of interoperable, digital quality measures. Adopting Universal Foundation measures allows CMS to compare outcomes across programs and helps identify gaps in care. There are two foundational measure sets, Adult and Pediatric (Child), and three add-on measure sets, Maternity Care, Hospital and Post-Acute Care. ### Advancing Health Care Safety for All

CMS plays a crucial role in improving health care safety and reducing harm to patients. CMS has outlined a three-point plan to enhance patient safety that reflects the Agency's commitment to a coordinated effort to prevent harm. *Advancing Health Care Safety for All* is focused on (1) promoting transparency, (2) advancing safety culture through partnerships, and (3) incentivizing zero harm.
