

- Private and independent nonprofit agency
- Helps protect the legal rights of Native Americans with disabilities who live in the Four Corners of Arizona, Colorado, New Mexico, and Utah







#### What We Do

Provide advocacy, referral information, and educational resources to all Native Americans with disabilities living in the Four Corners region

- Monitor facilities on the Navajo Nation (group homes, detention centers, etc.) to make sure people with disabilities are provided with the services they need in the least restrictive environment
- Provide legal advocacy and representation in disability-related discrimination (housing, employment, education, voting, etc.)
- Provide advocacy and legal representation to Native American students with disabilities in education-related issues





## Monitored Congregate Care Facilities, Group Homes, and Day Habilitation Programs





#### **Benefits Enrollment Center**

Serving Native American elders and adults with disabilities since 2018, Benefits Enrollment Centers focus on connecting Medicare beneficiaries with limited incomes to benefits that pay for health care, food, and more.





### **Success Story**

We assisted Ben, a 36-year-old Navajo man with a traumatic brain injury from Gallup, New Mexico. Ben is:

- A single parent of two, and
- Is self-employed, making and selling jewelry.

Ben contacted the Law Center's Benefits Enrollment Center to get assistance with Supplemental Nutrition Assistance Program (SNAP).

We were able to assist Ben by filling out the SNAP application online—additionally, Ben qualified for the Emergency Rental Assistance Program, Medicaid, and the Low-Income Home Energy Assistance Program.

During the past 11 months, the Law Center has helped 226 elders and adults with disabilities receive the benefits for which they are eligible.
