



## Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) Quick Reference Guide

The IMPACT Act of 2014 mandated the establishment of the SNF QRP. As finalized in the Fiscal Year (FY) 2016 SNF PPS final rule, beginning with FY 2018 and each subsequent FY, the Secretary shall reduce the market basket update (also known as the Annual Payment Update, or APU) by 2 percentage points for any SNF that does not comply with the quality data submission requirements with respect to that FY.

SNFs utilize the Minimum Data Set (MDS) 3.0 via the Internet Quality Improvement and Evaluation System (iQIES) to collect patient assessment data. The implementation of the SNF QRP will not change requirements related to the submission of MDS 3.0 data through iQIES.

If the required quality data is not reported by each submission deadline, the SNF will be subject to a two (2)-percentage point reduction in their annual payment update (APU).

### Frequently Asked Questions

*Q: How do I verify my National Healthcare System Network (NHSN) data submission?*

The best way to verify your current NHSN data submission is by running the Centers for Medicare and Medicaid Services (CMS) report found in the Analysis Reports section of NHSN. Detailed guidance on how to run and interpret CMS reports and all other NHSN reports, as well as a checklist used to ensure complete reporting on NHSN, can be found on the Centers for Disease Control and Prevention ([CDC NHSN home page](#)). *Q: How is NHSN compliance determined?*

For NHSN data, facilities are required to report data for one week of each calendar month, with three months of data due by each submission deadline (for example, Q4 data encompasses October-December and is due May 15 of each year). Facilities that submit complete data for all twelve months will be found compliant with the NHSN measures. *Q: Are swing beds subject to the requirements of NHSN COVID-19 Vaccination Coverage Among Healthcare Personnel?*

Swing beds are not required to submit COVID-19 Vaccination Coverage among Healthcare Personnel (HCP) data under the SNF CMS Certification Number (CCN). The CDC has

determined that reporting will be required under the parent hospital CCN to ensure duplicate information is not submitted. Swing Bed NHSN data submitted under the parent hospital CCN will not affect SNF APU determinations.

*Q: Are Swing Beds subject to the NHSN Influenza Vaccination Coverage among Healthcare Personnel data requirements?*

Swing beds are not required to submit Influenza Vaccination Coverage among Healthcare Personnel data under the SNF CMS Certification Number (CCN). The CDC has determined that reporting will be required under the parent hospital CCN to ensure duplicate information is not submitted. Swing bed NHSN data submitted under the parent hospital CCN will not impact SNF APU determinations.

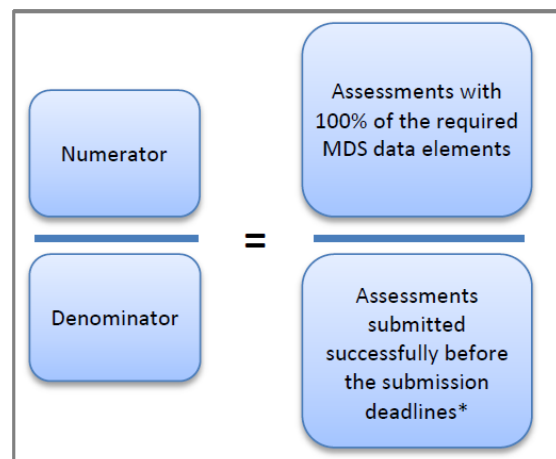
*Q: How do I verify my MDS assessment submission?*

The best way to verify that your current MDS assessment data submission has been accepted into iQIES is by reviewing the final validation reports. Detailed guidance on how to access reports can be found in the [iQIES MDS User Guides and Manual](#). Select “CMS iQIES Reports User Manual” to open the PDFs. An additional resource, the CMS iQIES MDS Upload an Assessment guide, is available on the same page.

As you review your error messages, be sure to correct any instances where the value submitted for the quality measure item is a dash (-). Entering a dash as a response to a quality data item may result in your facility not meeting the required threshold for that quality data item.

*Q: How are SNF QRP thresholds calculated?*

The SNF QRP threshold is calculated by taking the total number of assessments with 100% of the required MDS data elements (numerator) divided by the number of successfully submitted assessments (denominator). The resulting number is multiplied by 100 to determine the threshold percentage. Generally, MDS records submitted for patient admissions and/or discharges occurring during the reporting period will be included in the denominator. Beginning with FY 2026, facilities



must submit 90% or more of all assessments with 100% of the required MDS data elements to be in compliance with SNF QRP requirements.

Beginning with FY 2026 compliance determination, if during the reporting period (01/01/2024-12/31/2024) a facility has submitted 1000 assessments and 900 of the assessments submitted have 100% of the required MDS data elements, the threshold percentage would equal 90%. Thus, the facility would be deemed compliant with SNF QRP data reporting requirements for APU compliance purposes.

The SNF QRP Table for Reporting Assessment-Based Measures is available by Fiscal Year (FY) and outlines which MDS items are required for the purposes of APU compliance for the given Fiscal Year. The tables for the current and future Fiscal Years can be found in the Downloads section on the [Skilled Nursing Facility \(SNF\) Quality Reporting Program Measures and Technical Information](#) webpage.

*\*Note: The calculation algorithm will be adjusted if the SNF is granted an extension or exemption by CMS.*

*Q: When is a new SNF required to begin reporting SNF QRP data?*

As stated in the [FY 2016 SNF PPS final rule](#), a new SNF will be required to begin reporting data on all quality measures finalized for that program year by no later than the first day of the calendar quarter subsequent to 30 days after the date on the SNF's CMS Certification Number (CCN) notification letter. The calendar quarters always begin on the following days: January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup>, and October 1<sup>st</sup>.

EXAMPLE: If a SNF received its CCN on August 28, 2017, and 30 days were added (August 28 + 30 days = September 27), the SNF would be required to submit data for residents who are admitted beginning on October 1, 2017.

*Q: Are swing beds subject to SNF QRP requirements?*

According to the FY 2016 SNF PPS final rule ([80 FR 46429](#)), critical access hospitals (CAHs) with swing beds are not required to submit quality data under the SNF QRP.

*Note: Non-CAH swing beds are subject to SNF QRP requirements. For more information about requirements for swing bed facilities, refer to the [SNF Prospective Payment System \(PPS\) Swing Bed](#) webpage.*

*Q: What measures are required for the SNF QRP?*

The table below outlines the required assessment-based measures and the data submission mechanism for those measures.

\*Data collection for this measure begins on October 1, 2024.

Claims-based measures are also included in the SNF QRP. These measures are calculated through Medicare Fee-For-Service claims data and do not require SNFs to submit any additional data to CMS.
