MACRA Episode-Based Cost Measures – Psychoses/Related Conditions Clinician Expert Workgroup

Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Acumen, LLC (“Acumen”) to develop care episode and patient condition groups for use in cost measures to meet the requirements of the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). The contract name is “Physician Cost Measure and Patient Relationship Codes (PCMP).” The contract number is 75FCMC18D0015, Task Order 75FCMC19F0004. As part of the development and maintenance processes, Acumen convenes groups of stakeholders and experts who contribute direction and thoughtful input during development of episode-based cost measures.

The project’s overall objective is to develop episode-based cost measures suitable for potential use in the Quality Payment Program. Acumen’s measure development approach typically includes convening clinician expert panels called Clinical Subcommittees (CS) focused on particular clinical areas in cycles of development (“waves”). In addition to our typical development cycle, which involves 4 measure areas as part of Wave 4, Acumen is also convening a workgroup in both October 2021 and March 2022 to further refine the Psychoses/Related Conditions measure which was one of 11 episode-based cost measures developed by Acumen between April through December 2018.
