SUBJECT: Revision to State Operations Manual (SOM) Appendix PP

***Revised to Reflect Minor Technical Updates to Tags Listed on Page 2 ***

Memorandum Summary

- **Revised Regulations:** On September 28, 2016, the Centers for Medicare & Medicaid Services (CMS) released revised requirements for participation under the Medicare and Medicaid Programs; Reform of Requirements for Long-Term Care Facilities rule. Many of the regulations were re-designated and have new numbers.
- Revisions to SOM Appendix PP: CMS has revised regulation text into the SOM Appendix PP to correct identified technical errors and correct the numerical order of tags. The revised version was released on February 10, 2017. The regulation text is effective November 28, 2016; the Interpretive Guidance has not been updated. Interpretive Guidance will be revised at a later date.

Background

Consolidated Medicare and Medicaid requirements for participation for Long Term Care (LTC) facilities (42 CFR part 483, subpart B) were first published in the Federal Register on February 2, 1989 (54 FR 5316). Revisions to these requirements were released on September 28, 2016 and became effective as of November 28, 2016.

Appendix PP

CMS previously released a version of Appendix PP that incorporated the new regulations into the SOM. This most recent version of Appendix PP issued on February 10, 2017 has made technical corrections where regulatory text needed to be addressed and certain subsections of the regulation had to have the numerical order corrected. CMS will be issuing a subsequent version of Appendix PP with updated Interpretive Guidance and a re-ordering of F-Tags at a future date. **Only Phase 1 regulatory text is effective in this version of Appendix PP.** We have included Phase 2 and Phase 3 language, but have distinguished these provisions within Appendix PP and have listed their effective dates.
