New Data-Submitter Tips

If you are a new user entering and submitting data, here is what you need to know:

Register for *CMSNet* and secure a CMSNet User ID on the Quality Improvement and Evaluation System (QIES) Technical Support Office (QTSO) website at [CMSNet Online Registration](#).

Next, register for a QIES User ID. Once logged into the CMS Network, select the "IRF-PAI" link to open a screen where the IRF User Registration application link resides. The QIES User ID is needed to submit IRF-PAI assessments to the QIES Assessment Submission and Processing (ASAP) system and allows access to the submission reports in the Certification and Survey Provider Enhanced Reports (CASPER). CMS provides training available on the QTSO website.

<p>Please Note: The CMSNet and QIES User IDs are not used for submission of Healthcare-Associated Infection (HAI) data to the CDC/NHSN.</p>

Registration for NHSN and SAMS

Because the user IDs listed above do not provide access for submission of HAI data, users need to register for Secure Access Management Services (SAMS) login credentials and register for CDC/NHSN in addition to registering for QIES and CMS Network credentials.

Reconsideration Request Information

The process for filing a request for reconsideration is described on the [IRF Quality Reporting Reconsideration and Exception & Extension](#) page.

CMS will only consider requests for reconsideration after a provider has been found to be non-compliant. The facility must have received a CMS letter of noncompliance in order to apply for reconsideration.

Reconsideration requests and supporting documentation must be submitted via email with the subject line: IRF ACA 3004 Reconsideration Request and your IRF CCN (e.g. IRF ACA 3004 Reconsideration Request, CCN = XXXXXX) to the following email address: IRFQRPreconsiderations@cms.hhs.gov.

CMS will review the IRF documentation and determine whether evidence to support a finding of compliance has been provided. The determination will be made based solely on the documentation provided. If clear evidence to support a finding of compliance is not present, the 2 percentage point APU reduction will be upheld. If clear evidence of compliance is present, the reduction will be reversed.

Appeal Process Information

If the CMS determination upholds the 2 percentage point APU reduction, a statement of the findings to support the decision will be provided to the request email contact. The IRF will be notified in writing and informed of the right to further appeal the 2 percentage point APU reduction using the appeals process detailed in 42 CFR Part 405, Subpart R via the [Provider Reimbursement Review Board](#) (PRRB).
